## State Library Resource Center (Liz Sundermann-Zinger)

Looking at MOU – Commission will give feedback.

The update that would most interest this group is,

"SLRC is to operate a wide area network (WAN) that: provides Internet access for public libraries, local governments, and municipalities; hosts websites; maintains an online Public Library Directory.

- 1 Effective July 31. 2009, the SLRC shall provide for periodic audits to ensure adequate security controls over the SAILOR network systems.
- 2. The SLRC will conduct an annual audit of SAILOR security controls to ensure for continuous and secure network services.
- 3. The SLRC will submit and implement a corrective action plan based on any serious deficiencies identified in the annual audit to MSLA within 30 days of the final audit findings.
- 4. The SLRC will provide regular monitoring of the network and will keep records about up time, average speed, and other quality indicators. The SLRC will ensure that these data points adhere to the current agreed upon standards, varying as technology changes."
